## Support for Youth Education through Battle River Power Coop Scholarships: 2025 Applications OPEN!

Are you a proud Battle River Power Coop member with a child or grandchild ready for post-secondary education? We're here to help with scholarships for members' dependents, supporting their future every step of the way.

As part of our commitment to community and cooperative principles, Battle River Power Coop proudly supports the education of youth within our membership. Each year, we offer five \$1,500 scholarships to dependents of members in good standing who are entering their first year of post-secondary education in a diploma or degree-granting program.

Eligible students must be high school graduates from the previous or current school year, and applications are due by Friday, February 14, 2025. To apply, students must meet specific requirements, including submitting transcripts, proof of registration, letters of reference, and a personal statement.

## Battle River Power Coop's New Residential Rate: Now Accepting Applications

Battle River Power Coop is accepting applications for our new Residential Rate. This offering provides significant savings opportunities for qualifying members on monthly Distribution Tariff (DT) rates.

The Residential Rate is available to members with sites consuming under 9,000kWh per year, with a single household using electricity predominantly for domestic purposes and serviced by a single meter at a standard capacity. This rate applies whether the site is owned by an individual or a corporate entity.

Enrollment is on a first-come, first-served basis and will be capped at 50 members per month, so early application is encouraged. Thank you for your continued support as we work to enhance our services and offer competitive rates to our members.

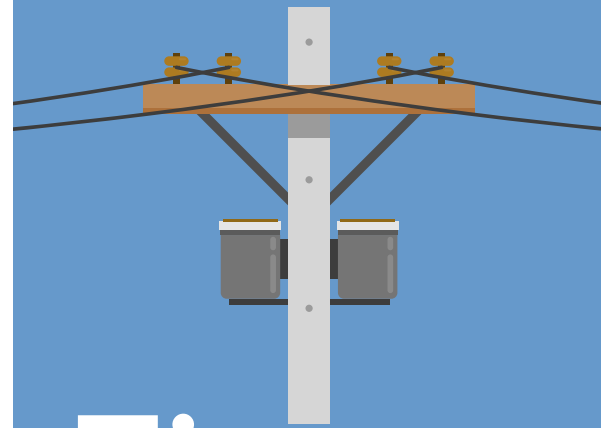

## New Rate of Last Resort Approved for BRPC Members

For December 2024, the RRO is priced at \$0.14264 per kWh, reflected on your enclosed blue bill. For January 1, 2025 to December 31, 2026, the BRPC Rate of Last Resort is \$0.1300 per kWh. Detailed information on the monthly RRO is available on: [www.brpower.coop](http://www.brpower.coop). The RoLR rate will replace the current Regulated Rate Option (RRO). Members currently on the RRO will be automatically transferred to the new RoLR starting January 1, 2025.

Battle River Power Coop remains dedicated to offering competitive energy options. Whether you are a small or large consumer, eligible members can explore our fixed contract options. For those interested in other alternatives, you are welcome to visit the Utilities Consumer Advocate (UCA) at [www.ucahelps.alberta.ca](http://www.ucahelps.alberta.ca) or call 310-4822 (toll free in Alberta) to explore a range of energy retailers.

To help members make informed choices, the UCA will also reach out quarterly to those on the RoLR, advising them on available retailer alternatives. We encourage you to take advantage of these updates to understand your options better.
