Bill Klassen: CEO Report 2025 AGM

On June 19th, Battle River Power Coop and Frontier Energy held their Annual General Meeting. At this meeting we reflected on our rapidly changing industry and BRPC's place in it. That's why this year, the theme was: **"Battle River Power Coop... A Catalyst for Change."**



Last year, we celebrated our 75th anniversary - a milestone that gave us the chance to honour our cooperative legacy.

This year, we turn our focus forward. That's why the theme of this year's AGM is "A Catalyst for Change."

We believe Battle River Power Coop is uniquely positioned to lead. As one of Alberta's largest Rural Electrification Associations, we're proving that affordability and reliability are not mutually exclusive.

Last year, we took a bold step toward this vision with the launch of our energy division: Frontier Energy by Battle River Power Coop. Frontier Energy offers members a competitive fixed energy rate - providing predictability, affordability, and the peace of mind that comes from being part of a cooperative.

Because we're a cooperative, your dollars stay close to home. With Frontier Energy, members don't have to choose between the cooperative and the competitive option - they get both.

We believe this is what all Albertans should expect from their electricity providers: prudent management, reliable service, and fair pricing.

Of course, not everyone sees our success as a good thing. There are powerful interests who would prefer we were not in the picture.

That is why we are stepping up our advocacy efforts. We are building stronger relationships with decision-makers, amplifying the voice of REAs, and standing up for electricity consumers across Alberta.

We will continue to fight for fairness and affordability. We will continue to hold ourselves accountable and improve wherever we can. And by putting ourselves forward as an example of what a well-run, fairly priced utility looks like, we believe we can truly be a catalyst for positive change.

Let's look at the numbers:

- In 2024, the transmission rate year over year experienced a 17% reduction.
- In 2025, we expect a further 9% savings in Transmission charges.
- Members on the Frontier Energy fixed energy contract saved approximately 19%.
- Members on the new residential distribution tariff rate saved an average of 41%.
- Our Administration fee is 12.5% lower on average for paper invoices, and 25% lower for electronic bills.

We've improved service too:

- A 26% reduction in member outages.
- Unplanned outages dropped by 31%.
- 2,200 fewer members experienced a power disruption.
- Our members see a 40% faster recovery time than those served by the investor-owned utility.
