



Battle River Power Coop's New Residential Rate: Now Accepting Applications

Battle River Power Coop is accepting applications for our new Residential Rate. This offering provides significant savings opportunities for qualifying members on monthly Distribution Tariff (DT) rates.

The Residential Rate is available to members with sites consuming under 9,000 kWh per year, with a single household using electricity predominantly for domestic purposes and serviced by a single meter at a standard capacity. This rate applies whether the site is owned by an individual or a corporate entity.

Enrollment is on a first-come, first-served basis and will be capped at 50 members per month, so early application is encouraged. Thank you for your continued support as we work to enhance our services and offer competitive rates to our members.

Message from the Board of Directors

We are excited to announce that Battle River Power Coop is now accepting applications for our new Residential Rate! Eligible members may save an approximate average of **\$24.00 per month** on their Distribution Tariff rates by switching.

The Residential Rate is available to members with single households, using electricity predominantly for domestic purposes, serviced by a single meter at standard capacity and consumes 9,000 kWh per year or less. This opportunity is open to both individual and corporate members of Battle River Power Coop.

Please note that enrollment is on a first-come, first-served basis and will be limited to 50 members per month. We encourage you to apply early to secure your spot and take advantage of these potential savings.

REGULATED RATE OPTION



The RRO may increase or decrease from month to month as it is priced on the open market and subject to many factors relating to supply and demand. It is not a 'regulated' rate, rather it is a default rate. If you do not have an energy contract, then you are on the RRO.

For October 2024, the RRO is priced at \$0.11242 per kWh, reflected on your enclosed blue bill. For November 2024, the REA monthly rate as calculated under the RRO regulation is \$0.11080 Detailed information on the monthly RRO is available on: www.frontierenergy.coop.
