



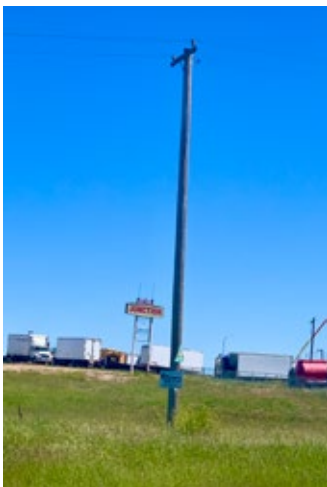

Stay Safe: Keep Power Poles Clear!

Attaching signs, posters, birdhouses, or other items to power poles or placing them too close to poles may seem harmless, but it can pose serious safety risks and cause operational challenges for utility workers and the public.



1. Worker Safety

Power poles are regularly accessed by utility workers who perform maintenance or emergency repairs. Nails, staples, screws, or any fasteners used to attach items to poles can damage the protective gear utility workers wear, such as insulated gloves and climbing equipment, increasing their risk of injury.

2. Interference with Maintenance

Anything attached to a power pole can obstruct maintenance tasks, slowing down repairs or routine inspections. Crews may need to remove these items, which can delay the restoration of power during outages.

3. Fire Hazards

Non-approved items on power poles can increase fire risks, especially in dry conditions. Electrical faults or sparks could ignite materials such as paper or wood, potentially leading to larger fires.

4. Legal and Liability Concerns

It is illegal to attach anything to a power pole. If someone is injured or damage occurs due to items attached to poles, you could be held legally responsible for the incident.

While it might seem convenient to use power poles for notices or decorations, it's vital to avoid this practice. Keeping poles clear ensures the safety of utility workers, prevents maintenance delays, and reduces fire hazards.

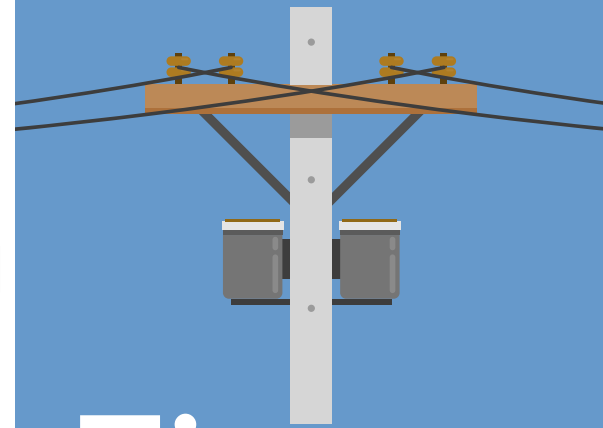

REGULATED RATE OPTION



The RRO may increase or decrease from month to month as it is priced on the open market and subject to many factors relating to supply and demand. It is not a 'regulated' rate, rather it is a default rate. If you do not have an energy contract, then you are on the RRO.

For September 2024, the RRO is priced at \$0.11893 per kWh, reflected on your enclosed blue bill. For October 2024, the REA monthly rate as calculated under the RRO regulation is \$0.11242. Detailed information on the monthly RRO is available on: www.frontierenergy.coop.
